## **MINUTES**

Minutes were called to Order by Mayor Quarles. The Pledge of Allegiance was done in Unison. Prayer was given by Minister Irene Tidwell. The following people were present: Mayor Quarles, Water Clerk/Recorder Patrice Evans, and Alisha Pearson, City Treasurer. Council Members present were: Kathy Dillard, Johnny Kelly, Violene Muldrow and Irene Tidwell. Guest attending the meeting were: Coach Bobby Mullins, Linda Mullins and Nevada County Reporter, John Miller.

After the minutes from the June meeting were read and one addition added by Mayor Quarles informing the Council that the City would have to have a bill pay source to allow customers to pay their bills online. He stated that more research and information is needed. Mayor Quarles then asked for a Motion to accept minutes as read. Kathy Dillard made a Motion to accept the Minutes. Johnny Kelly seconded the Motion. Motion carried.

### **Old Business**

1. **Road Construction:** Mayor Quarles informed the Council that he has completed his research on the road construction. The roads will be covered with Asphalt Milling. The Road beside City Hall and Scenic Drive will be completed. It is 1.7 miles. It will take 23 loads which will cost \$10,500. It will cost \$5,750 to haul and spread the asphalt, which will be done by Edd Cross. The total project will cost \$16,250. The County agreed to do the prepping of the roads. Council member Irene Tidwell asked the Mayor was it enough money to complete the project and he answered, "YES." Mayor Quarles then asked for a Motion to proceed. Kathy Dillard made a Motion to proceed, Irene Tidwell seconded the Motion, Motion carried.
2. **City Website:** Mayor Quarles informed the Council that the City Website can be accessed at [cityofrosston.org](http://cityofrosston.org). The Website will eventually include Advertisements, Community News, Resolutions and Ordinances adopted by the City. It will also include the City Budget and contact information for the City and Council Members.
3. **Baseball Park Meeting:** Mayor Quarles stated that he met with the City attorney, Mary Godwin and Brandon Rhodes. Mayor Quarles and Brandon Rhodes are looking at options for the property other than baseball fields. Mayor Quarles stated that some of the people in the community would like to see more of a recreation area which could include a walking trail, playground equipment and a pavilion.
4. **Mrs. Mullins:** Mayor Quarles informed the Council that Linda Mullins requested to be on the agenda. Mrs. Mullins requested permission from the City to install a billboard of the Nevada's championship team on the property between the City Hall and the Fire Station. The project will be at no cost for the City. She informed the Council that fundraisers will fund the project. Mayor Quarles stated that's a good idea. Mayor Quarles asked for a Motion to allow a billboard to be placed on City property. Kathy Dillard made a Motion to allow the billboard to be placed, Irene Tidwell seconded the Motion. Motion carried.
5. **Recognition:** Mayor Quarles presented Coach Bobby Mullins a plaque from the City of Rosston in recognition of the Championship Title. Coach Mullins was also recognized for his leadership

and commitment to the community. Mullins was also given a gift certificate from Barr's Junction. Coach Mullins thanks the City for support. He stated that he loved the community and the fact that the community looks out for each other.

6. **Motion to Adjourn:** After the presentation to Coach Mullins, Mayor Quarles informed everyone that refreshments are available. Mayor Quarles then asked for a Motion to Adjourn. Johnny Kelly made a Motion to Adjourn, Kathy Dillard seconded the Motion. Motion carried.
