MINUTES

Minutes were called to Order by Mayor Quarles. The Pledge of Allegiance was done in Unison. Prayer was given by Minister Irene Tidwell. The following people were present: Mayor Quarles, Water Clerk/Recorder Emily Evans. Council Members present were: Kathy Dillard, Johnny Kelly, Violene Muldrow, Irene Tidwell and Reporter John Miller.

After the minutes from the August meeting with no corrections, Mayor Quarles asked for a Motion to accept the Minutes. Johnny Kelly made a Motion to accept the Minutes. Irene Tidwell seconded the Motion. Motion carried.

New Business

1. **Budget 2021:** Mayor Quarles informed the Council that he along with the Treasurer are working on the 2021 Budget. He stated that not many changes will be made since the 2020 Budget because the current Budget has been effective. Mayor Quarles also informed the Council that the Water Revenue is good due to sending out shut-off notices. The City gained an extra \$3,000 to \$4,000. The City was hit with more than usual plumbing bills for the month due to valve repair.
2. **New Employee:** Mayor Quarles informed the Council that the current Water Operator, Ty Green has resigned to pursue another job. The Mayor, commended Mr. Green for the job he did for the City during his employment. The Mayor informed the Council that the City Operator job was posted after Mr. Green gave his two weeks' notice. There were three candidates that interviewed for the position. Tim Woods assisted the Mayor with the interviews. The decision was made to hire Derek Sisk. Council Member, Johnny Kelly asked the Mayor if the new Operator would have an assistant? The Mayor informed Mr. Kelly that Kyle Jenson would still assist the Operator as extra help.
3. **Budget Report:** Mayor Quarles present the Council with a copy of all City's bank accounts to bring everyone up to date on the City's Finances. The Mayor reminded the Council that his goal has been to have at least \$300,000 with all accounts combined. The total of all accounts was \$282,405.77 as of September 14, 2020. Mayor Quarles also informed the Council that the Baseball Park is not property of the City of Rosston. Council Member, Johnny Kelly asked the Mayor if the park still consist of just baseball? Mayor Quarles informed Kelly that park would consist of a variety of activities. Mayor Quarles informed the Council that he would be meeting with Mary Goodwin in the near future to discuss looking for matching grants for the park. Mayor Quarles stated the he would keep the Council informed as it progresses.
4. **Motion to Adjourn:** After all discussions, Mayor Quarles asked for a Motion to Adjourn. Kathy Dillard made a Motion to Adjourn. Johnny Kelly seconded the Motion. Motion Carried. Meeting Adjourned.
