After the minutes from the November meeting with no corrections, Mayor Quarles asked for a Motion to accept the Minutes. Irene Tidwell made a Motion to accept the Minutes. Johnny Kelly seconded the Motion. Motion carried.

New Business

- 1. Water Project: Mayor Quarles informed the Council that a Representative (Kiron Browning) from A.L. Franks Engineering was attending the meeting to present the bids for the Water Project and to recommend that the Council accept the bids. Core and Mains were rewarded the bid for the Water Meter Replacement Project with a bid of \$180,867.50 which was \$4,132.50 under the budget for the project. Mr. Browning the presented the bid for the Tank Improvements. He recommended the Council accept the bid of Cunniinham Sandblasting & Painting for \$220,150.00 which is \$9,850.00 under the budget for the project. After Mr. Browning's presentation, Mayor Quarles asked for a Motion to accept the bids presented, Johnny Kelly seconded the Motion. Motion carried.
- 2. Ordinances: Mayor Quarles asked for a Motion to introduce Ordinance No. 12-20 carrying a file mills in all real and Personal Property within the City of Rosston to the Council. Irene Tidwell made a Motion to introduce, Johnny Kelly seconded the Motion. Motion carried. After the introduction of the Ordinance, Mayor Quarles ask for a Motion to proceed with the Ordinance.
